Public Hearing on LEGISLATIVE CASE RZ-23-12, Hyundai Automotive Dealership, a conditional district rezoning filed by Drew Wilkinson on behalf of 10012 CBM LLC, 2517 BMC LLC, and Naught 1 LLC, to rezone 11.16 acres located at 10012 Capital Boulevard and 2517, 2601, and 2605 Burlington Mills Road, being Wake County Tax PIN(s) 1738497725, 1738499517, 1738592719, and 1738593572, from Highway Business (HB) and General Residential (GR3) to Highway Business Conditional District (HB-CD).

Senior Planner Tim Richards provided an update on the following revised & new conditions:

Revised Condition #8:

- Town has 60 days following approval of rezoning to provide survey for 2521 and 2525 Burlington Mills Rd for those frontage improvements to be included in developer's construction plans
- Town or NCDOT still must acquire the right-of-way before developer starts construction for developer to construct those improvements at developer's cost

New Condition #10:

• Stormwater control measures must attenuate peak flow leaving the site for the <u>25-year</u>, 24-hour storm to pre-development condition (draft UDO standard)

Toby Coleman from Smith Anderson represented Johnson Automotive and presented information about the new Johnson Hyundai Site.

Travis Fluitt, a Transportation Engineer with Kimley-Horn Associates, addressed the Board but could not confirm whether the intersection at Urial Dr. and Burlington Mills Rd. currently meets the necessary requirements for a traffic signal. He mentioned that they had been operating under the assumption that the development to the south would install the signal and had committed to doing so. If it is later determined that a signal is warranted, they will proceed with its installation. Mr. Fluitt noted that this development alone would not create the need for a traffic signal.

Mayor Jones asked if there was anyone else that wanted to speak. No one came forward to speak.

Mayor Jones declared the public hearing closed.

7. Planning Items

7.A. Consideration of LEGISLATIVE CASE RZ-23-11, 418 Jones Dairy Road, a rezoning filed by TMTLA Associates to rezone 5.61 acres located at 418 Jones Dairy Road, being Wake County Tax PIN 1850155522 from Light Industrial (LI) and Rural Holding District (RD) to Neighborhood Business Conditional District (NB-CD).

Commissioner Wright raised concerns about water runoff. Landscape Architect Randy Porter from TMTLA Associates explained that they are now committing to managing a 25-year, 24-hour storm event, which aligns with the new draft Unified Development Ordinance (UDO).

Commissioner Cross inquired whether using permeable pavers would improve the parking area. Mr. Porter responded that permeable pavers require near-level or flat slopes, which are unsuitable for the site's topography. Commissioner Cross then asked if the buildings could function with fewer parking spaces and how the current number had been determined. It was explained that the number of spaces was based on the anticipated use of the medical office and commercial areas, following the guidelines set by the UDO. Mr. Porter noted that there would be room for evaluation as they move toward the construction drawings and further define the actual tenants or users of the property. Civil Consultant Mike Stocks also mentioned that a sand filter would be installed in the far parking lot to manage stormwater, specifically to attenuate runoff from a 25-year, 24-hour storm event.

Commissioner Wright asked how they would capture water in the parking lot given its slope. Mr. Stocks said water would be collected in catch basins, channeled through pipes, and directed to an underground system.

Commissioner Wright requested additional information about the lighting at the back of the lot. Mr. Porter discussed the existing vegetation, supplemental screening plantings, and the current forest vegetation. He mentioned that the proposed plants include eastern red cedar, wax myrtle, and yaupon holly. He believes the combination of these new plantings and the existing vegetation will provide sufficient screening of vehicular headlights.

Commissioner Cross inquired about prioritizing the traffic light, regardless of any developments. She noted that there is currently one right-hand turn lane on Burlington Mills Rd. at Capital Blvd. and asked if it would be possible to add a second right-hand turn lane to help manage the volume of vehicles. Mr. Richards explained that an analysis had been conducted to assess where traffic currently backs up and what potential future backups might occur with these improvements. He noted that the

challenge lies with the traffic signal, and NCDOT is unlikely to approve dual lanes there due to implications for signal timing. However, Mr. Richards stated that extending the right-hand turn lane along the frontage should significantly help alleviate the issue.

- Mr. Richards explained that an analysis had been conducted to assess where traffic currently backs up and what potential future backups might occur with these improvements. He noted that the challenge lies with the traffic signal, and NCDOT is unlikely to approve dual lanes there due to implications for signal timing. However, Mr. Richards stated that extending the right-hand turn lane along the frontage should significantly help alleviate the issue.
- Commissioner Wright asked about a development agreement, specifically if a traffic light is warranted, and whether they would be open to negotiating an agreement with the other developer.
- Assistant Planning Director Jennifer Currin indicated that the condition depends largely on the other developer agreeing to contribute financially to a project for which they might not currently have funding. Without the other developer present to discuss their current timeline or financial commitments regarding the project to the south, she is reluctant to move forward with conditioning both developments together. If a traffic signal is required due to existing conditions, it is more likely to be a Capital Improvement Project for future consideration rather than a requirement of the developer.

Vote: Motion carried 5-0.

8. Administration and Financial Items

8.A. Consideration of Approval Amending the Parks & Recreation Impact Fees.

The Board discussed the Parks & Recreation Impact Fees and approved an 80% adoption percentage paid over 5 years beginning July 1, 2025.
