The Wake Forest Historic Preservation Commission met on **25 February 2025**, at **6:30 p.m.** in the Board Room at Wake Forest Town Hall, 301 S Brooks Street.

5. Treasurer's Report

Paige Regna presented the Treasurer's Report for January 2025.

6. Public Hearing

Public Hearing: COA-25-02: A request from Janet Rose for Amanda Rambo, owner of 239 N. Main St, Wake Forest being Wake County Tax PIN 1841-43-9040, to approve roof replacement and secondary chimney removal.

Chairperson, Elizabeth Miller opened the public hearing at 6:32pm. Paige Regna, Planner 1-Historic Preservation, was sworn in to present the COA-25-02 application and staff report.

Jason Mobraten asked about the flashing material. Senior Planner, Michelle Michael, was sworn in and answered that the current flashing material is varied. The new flashing material will be consistent to avoid deterioration caused by incompatible materials.

Janet Rose, applicant, of Conway Design was sworn in and explained the project in detail and clarified a portion of the kitchen addition roof will be replaced with black rubber membrane. She also stated they had decided to use copper as the flashing material and roof material for the porch, side porch, and bay window. The slate roof will be replaced with CertainTeed Belmont shingles in the color Colonial Slate.

Public Comment: John Hearn, 126 North Avenue, Wake Forest, spoke in support of the project with no restrictions.

Elizabeth Miller closed the public hearing at approximately 7:00pm.
